Report of the Vice-President (Ken Graham)

Item #1 – Prizes

We received a healthy number of submissions for the Erasmus and Montaigne prizes after the 2019 conference – nine for the Erasmus Prize and six for the Montaigne Prize.

Erasmus Prize

The 2019 Erasmus Prize for the best paper by a student member is awarded jointly to **Colin J. Keohane** and **Kirsten Schuhmacher** (University of Victoria) for their paper, "University of Victoria McPherson Library's 1610 *Actes and Monuments*: A Users' Guide." Primarily a case study of book-as-artifact, the paper probes physical clues such as handwritten marginalia and bookplates to recover glimpses of four centuries of interaction between one physical book and a variety of human histories. The authors find evidence connecting previous owners to Quakerism and Freemasonry – later expressions of Protestant religious dissent – and they reconstruct what they term "a charming domestic moment" of writing practice. The committee praised the paper's methodological soundness, including the care with which it distinguishes facts from inferences. They also appreciated the skill with which the authors fashion their research as a detective story, and enjoyed the witty final section, "The Fly Swatter: Early Debugging."

Montaigne Prize

The 2019 Montaigne Prize for the best paper by a non-student member is awarded to **Erin Kelly** (University of Victoria) for her paper, "Jacobean Martyrs and Pseudo-Martyrs: Making History with the 1610 Edition of Foxe's *Actes and Monuments*." A combination of book history and post-Reformation religious history, Kelly's paper asks what it meant to publish a new edition of Foxe's tome in 1610. Her paper places the publication in a context that includes the 1605 Gunpowder Plot, the 1606 Oath of Allegiance, and an international debate about the meaning of true martyrdom. In this context, she contends, small choices of book design helped the publisher to reinforce Jacobean policy regarding Catholics and to locate martyrdom in the past rather than a contested present. The judges admired Kelly's skill in telling a complicated history with clarity and a tight focus, and especially commended her resourcefulness in constructing a coherent and persuasive argument from some quite different types of evidence.

The CSRS / SCÉR expresses gratitude to the members of the awards committee, Victoria Burke, Deanne Williams, and chair Ken Graham, for their careful readings of the submissions. The final decision on the Montaigne Prize was made by Victoria and Deanne only. The awards committee thanks all those who submitted their conference papers. With revisions, all of these papers would be publishable, and we encourage the authors to submit their work to the journal *Renaissance and Reformation / Renaissance et Réforme* in the near future.
