Canadian Society for Renaissance Studies Annual General Meeting June 1, 2025, George Brown College, Toronto, 548D

12:55pm, The President, Elizabeth Sauer, called the meeting to order and thanked everyone for attending.

1. Land acknowledgement (above)/Reconnaissance du territoire (ci-dessus)

12:55pm, The President delivered the land acknowledgement previously circulated.

2. Adoption of the Agenda/Adoption de l'ordre du jour

12:56pm, there was no discussion or opposition to the agenda.

**MOTION:** That the membership approve the agenda for the AGM. (Brain/Woodford)

There was no opposition to the motion, so it was unanimously accepted.

3. Adoption of the minutes (from previous AGM)/Adoption du procès-verbal de la précédente AGA \*

Approval of the minutes

**MOTION: That the membership approve the minutes from August 2, 2024.** (Pentland/Linda Steele)

There was no opposition to or further changes to the minutes, so they were unanimously accepted.

4. Presentation from Lana Galbraith, Manager, Member Engagement, Member Support / Assistance aux members / Federation for the Humanities and Social Sciences / Fédération des sciences humaines

Sauer indicated that the group was having its fiftieth anniversary conference and would need to be held in person before turning things over to Galbraith.

Galbraith indicated the following:

- That the fact we were at a College this year spoke to the changing landscape in postsecondary and how the Federation is adapting to change;
- That the Federation is coming up with a strategic plan that will address recent issues with trying to find locations and keeping Congress going;

- That there would be forthcoming meetings based upon the fact that Congress 2026 is online; and
- That the Federation was willing to listen to advice and take contributions from member organizations on future of Congress

Sauer presented questions to Galbraith:

- Question of dues: that they are necessary to be a part of Congress, and Galbraith also indicated additional ways that Congress dues were used. Benefits for Congress with funding and awards right now. The only real benefit to remaining that was expressed is that the society would be part of the conversation about what the future of Congress looks like. Sauer made it clear that if we were paying membership dues to the Federation, then the Society would need access to the benefits (i.e., Graduate Student Merit Awards for the in-person gathering next year).
- Receiving the EDID funding: not contingent on being a member to keep it within the timeline. We have access to the funding until the expiring date of the funding (2027), so that is not necessarily an issue. (But to apply again we must be a member of Federation in good standing.)
- Future 2027 and 2028 gatherings at in-person venues. They have not secured any institutions, but they are working to find a university.
- On advocacy work, Galbraith pointed to one meeting that occurred recently with respect to advocating for the value of humanities that she could share. In general terms, she spoke of continuing efforts to work with Tri-Agency administration; to work on improvements to open-access models; to develop a blind-spot alarm policy; to advocate for caution with regard to replacing distinct humanities departments with general cultural studies departments

The floor was then opened to attendees to ask questions.

- Questions about what exactly the issue was with securing the host came up. The Federation was nearing the end of a deal with an institution, but complications arose from what the institution needed from the Federation.
- Questions about what the in-person component was; the answer made it sound like it was
  to have meetings about future Congress in ten rooms somewhere. If there is a small inperson component next year, of perhaps 2000-3000 people, perhaps hybrid, it will
  not be branded as Congress.
- 5. Report of the President (Sauer)

Sauer reviewed her report and took questions. Hearing none, she moved on.

6. Report of the Vice President (Pentland)

No report was submitted.

### 7. Report of the Treasurer (Woodford)

The budget was presented on screen. There were no questions.

8. Report of *Renaissance and Reformation* Editor (Bowen)

A copy was sent around this morning. It was reviewed on the screen. Sauer indicated that if there were questions or comments for Bowen later, please email him.

9. Report of Graduate Student Representative, Représentant des étudiants de cycles supérieurs (Seguin-Brault)

No report submitted. Indicated that we will need a new graduate student representative in the near future.

10. Report of the Secretary (Kaethler)

Kaethler provided their report and elaborated upon the EDID fund in light of the information provided. There were no questions.

11. Report of the Past President (Graham)

No report was submitted.

12. Regional Representatives

Sauer directed our attention to the reports in the agenda package that were submitted.

13. Discussion of our 50<sup>th</sup> Anniversary Conference

In conversations with several colleges at the University of Toronto, and we have determined one college that is particularly interested.

Sauer provided an overview of the costs relative to the expenses to be part of the Congress.

There were conversations around a hotel venue and what the possibility is of securing one.

Conversations around previous meetings with ACCUTE and other societies. ACCUTE is doing a hybrid conference at the Alt Hotel next year with Congress.

Although Toronto seemed like a good option, Québec is where the Society began, so there was interest in looking at the University of Montréal. Vaillancourt indicated that he would look into these possibilities.

If conference-provider fees are unexpectedly high, we might be able to bring down graduate student registration fees to compensate.

We will eventually need to consider costs and benefits of remaining in Federation. "Going rogue" might offer benefit of increased mobility across Canada, with meetings in Atlantic provinces and West.

The current situation in the U.S. makes it even more important to keep our conferences regular.

# **2024 REPORT**

# WILLIAM R. BOWEN, EDITOR MAY 24, 2025

This brief report on *Renaissance and Reformation* | *Renaissance et Réforme* (R&R) draws attention to noteworthy changes and achievements during 2024.

### **EDITORIAL TEAM**

The relationship between *R&R* and the *Early Modern Digital Review (EMDR)* evolved during 2024 (see next paragraph) and I am grateful to Isabella Magni (Sheffield), associate editor for reviews of digital projects, for her contribution to that process. Associate editors Megan Armstrong (McMaster) and Renée-Claude Breitenstein (Brock) continued their exemplary work on special issues and book reviews respectively. Managing editor Olivier Séguin-Brault expertly kept us all on track and was instrumental in improving our operations.

# Early Modern Digital Review

The publication of *R&R* 47.4 marks the conclusion of a mutually beneficial relationship between our journal and the *EMDR*, which contributed reviews of digital projects and tools to a distinct section within the pages of *R&R*. The growth of *EMDR* since its launch in 2018 has now reached a point where the *EMDR* team has been offered new marketing and distribution opportunities, and they are well positioned to explore expanding the journal's scope by publishing articles aligned with the same distinctive focus on digital technology and early modern studies. Over the next few months, the *R&R* editors will consider how we might continue to contribute to the review of digital resources. Your recommendations and insights would be appreciated. In the meantime, please join me in congratulating the *EMDR* editorial team on their success

### **NATALIE ZEMON DAVIS PRIZE**

The 2023 Natalie Zemon Davis Prize for the best article in volume 46 was awarded to Adrien Aracil for "Des « Republiques » pour des « brouillons de Republiquains » ? Les rôles des assemblées politiques dans la définition d'une communauté politique protestante dans la France du premier XVII<sup>e</sup> siècle," 46.1 (2023), 49-77.

### Committee report

Based on meticulous research and trenchant analysis, "Des 'Republiques' pour des 'brouillons de Republiquains'?" asks us to reconsider the nature of Huguenot political assemblies after the Edict of Nantes. Rather than as bastions of rebellious republicanism imagined by seventeenth-century critics, Adrien Aracil interprets them as sites for thinking through the problem of representation and for constructing a short-lived Protestant political community within the kingdom of France. The article excels for its originality of approach, melding social and political history, in which an analysis of the social and religious identity of the French Reformed community is juxtaposed with

the consideration of the practice of representation that was at once both politicly expedient and performative. While focused specifically on the French Protestant assemblies between 1598 and 1629, the article contributes to a more general understanding of how politics could continue to be negotiated in the early modern period even after a legal framework had seemingly established a definitive regime. It also calls attention to the more limited definitions of republicanism, rooted in the choice of deputies to uphold a system of privileges, which could succeed within the bounds of a powerful monarchy. Original in its conceptualization, incisive in its reading of sources, thorough in its historiographical exposition, and cogently written, this article delivers admirably on multiple fronts.

Our heartfelt thanks go to the committee chair, Hilary J. Bernstein (UC Santa Barbara), and the committee members, Véronique Ferrer (Paris Nanterre) and Gillian Weiss (Case Western Reserve), and to Megan Armstrong for overseeing the adjudication process.

### **PRODUCTION**

In 2024, we published four issues, including a double special issue:

46.3-4 La querelle des genres: Paradoxes and Models for the "Perfection" of Women (12th–17th centuries). Edited by Mercedes Arriaga Flórez, Patrizia Caraffi, and Hélène Cazes.

We also made substantial progress on the last issues of volume 47 (2024) and anticipate their publication in early 2025.

### **UPDATES AND PREVIEW**

- Subject/Object and Beyond: Women in Early Modern France. Essays in Honour of Colette Winn. Edited by Nancy Frelick and Edith Benkov. R&R's first supplementary volume appeared in February 2024 in the book series, Reflections on Early Modernity | Réflexions sur la première modernité.
- *R&R's* second supplementary volume, *Constructing European Historical Narratives in the Early Modern World*, is scheduled to be published in 2025. It is edited by Hilary J. Bernstein, Fabien Montcher, and Megan Armstrong.
- The *Special Issue Guidelines* were updated along with the creation of a *Guest Editor Agreement* and minor changes to other public-facing texts.
- Progress continues to be made in making back issues of the journal available via Érudit. In 2024, the Érudit team started to work on v28.1 (2004) to v32.4 (2009).
- The project to align *R&R* with best practices in matters of equity, diversity, and inclusion continues to move ahead, albeit slowly. Samah Marei, an Iter fellow, joined us in the Fall, supporting the initiative through research and drafting a planning document. This project led to conversations with the CSRS-SCÉR about collaboration toward shared goals.

# Canadian Society for Renaissance Studies Atlantic Region: Annual Report, May, 2025 Todd Pettigrew, Professor, Cape Breton University

### 1. AMEMG Conference

This report begins with our friends in the Atlantic Medieval and Early Modern Group, an interdisciplinary association whose main function is organizing an annual conference. This year's event is hosted by Universite of Moncton and Crandall University and will be held October 24<sup>th</sup> and 25<sup>th</sup>.

# 2. Assembling an Atlantic Renaissance Communication list

In the past I have forwarded relevant CSRS messages to AMEMG, but since I do not wish to take too much advantage of their good will, and since their areas do not perfectly overlap with ours, and since not everyone in Atlantic Canada is part of that group, I am assembling a list of active Atlantic Renaissance/Early Modern researchers of my own.

I sent out a preliminary message to as many potential list members as I could quickly find online, explaining what I was doing, and have already received several friendly messages back, including many suggestions for additions to the list, and one piece of news that I share below.

# 3. Bunyan Society Conference

Dr Shannon Murray of UPEI is hosting the 11<sup>th</sup> Triennial meeting of the International John Bunyan Society in June. The group is an interdisciplinary society that looks at all things non-conformist from 1500-1800, so it has a strong Renaissance component. This year's theme is "Teaching the Nonconformists and Nonconformist Teaching."

# 4. <u>In Memoriam, Dr Scott Alexander Moir</u>

Finally, Atlantic Renaissance scholars were saddened and shocked to learn of the untimely death of Dr Scott Moir, a historian of Early Modern Scotland. Dr Moir taught at CBU for many years, after earning degrees at Laurier, McMaster, and Guelph.
